MANUFACTURER'S LIFETIME LIMITED WARRANTY

Attic Brite – The most energy efficient Roof Ridge Vent is now available to you. The purchased Attic Brite now comes with a Lifetime Limited Warranty. Our warranty complements your new roof shingle warranty. Many roofs now come with a Lifetime Warranty and our vent has a similar one. Not many ridge vents have a Lifetime Limited Warranty, but Attic Brite does. The amazing effect of our new light harvesting product will most likely outshine your new roof shingle.

Definite and Scope of Warranty

Attic Brite Ridge Venting System (hereinafter referred to as the "product") is hereby warranted by Attic Brite, LLC (hereinafter referred to as the "manufacturer") and is subject to the conditions set forth below.

Attic Brite is covered for a limited lifetime and protects the original purchaser from cracking, peeling, denting, corrosion, breakage, burning, and lightning transfers. In addition, Attic Brite will not suffer damage from hailstorms, normal snow weight pressure, curling or leaking when properly installed by an authorized contractor. All purchases must be registered within 45 days by Attic Brite, LLC.

Inception Date

The inception date shall be the date the product was purchased from an authorized retailer/dealer by the original purchaser. This product is not transferrable.

Light Transmission

The product will not lose more than 10% of its light transmitting capacity for a period of 10 years from the inception date. The product will not lose more than 1% per year in subsequent years beyond the initial 10-year period as a direct and exclusive result of solar radiation impact as measured to the procedures in ASTM-E-313-05.

Attic Brite must be installed by an authorized and qualified contractor for the warranty to be in effect.





Attic Brite will be long lasting, serviceable and provide years of enjoyment.

Limitations

The Attic Brite Lifetime Limited Warranty will apply if:

- Proof of purchase is presented from an authorized dealer
- The product is installed by an authorized contractor/installer
- The product is installed, stored and maintained in accordance with the manufacturer's instructions for use
- The surface bearing the UV protection is the only side exposed to direct sunlight and the effects of weathering in every and all cases
- Any decrease of light transmission is not a result of product alteration or damage caused by, but not limited to, misuse, extreme surface temperatures exceeding 270 degrees to minus 40 degrees (Fahrenheit), and acts of God
- Installation is not improper, and/or done by unauthorized person/company in noncustomary jobs, fashions, unauthorized repairs or attempted adjustments

Claim Requirements

Every warranty claim must notify the manufacturer in writing by certified mail within the warranty period, a description of the problem, photographs of the product alleged to have caused a breach, a copy of the sales receipt showing the authorized retailer and/or authorized installer, any other proof of purchase, the purchaser's address, phone number, together with this Lifetime Limited Warranty. The manufacturer reserves the right to inspect any and all of the product in place in the installed position. If the product is moved and/or altered in any manner outside of the provisions of the Lifetime Limited Warranty, all remedies are null and void. In addition, the manufacturer reserves the right to investigate independently the circumstances of such failure including the contacting of local weather institutes and other sources deemed appropriate. If upon the manufacturer's discretion the product is to be replaced, the original product must be returned to the manufacturer's warehouse for examination.

Compensation

In the event that the manufacturer is notified of product failure within the confines of the warranty requirements, the manufacturer will provide either replacement product or at approved option a refund of the original purchase price paid. The warranty does not cover the cost of removing the product or any inconvenience to original purchaser. The cost of structure fabrication or installation of the replacement product is the sole responsibility of the original purchaser. This warranty is nontransferrable to a new owner of the property registered within the 45-day initial registration period.





In the event that the manufacturer is duly notified of light transmitting capacity reduction after more than 10 years from the inception date, and a claim is made and approved, the manufacturer will sell product replacement to the original purchaser based on the following price formula: price will be calculated at a rate of 5% of the effective price at time of replacement multiplied by the number of years from replacement time to inception date, less ten years, but not exceeding 90% reduction from the manufacturers then effective price.

The manufacturer reserves the right to discontinue or modify any of its products, including color, shape and size, without notice to the original purchaser, and shall not be liable as a result of such discontinuation or modification. Replacement material may vary in color in comparison to the original product as a result of normal wear, tear, and weathering. If the manufacturer replaces any material under this Limited Lifetime Warranty, it may substitute products determined by the manufacturer in its sole discretion to be of comparable quality or price. The original purchaser will be solely responsible for any and all shipping and handling costs associated with the warranty.

Liability

The manufacturer's liability is limited to providing replacement product or refund as set forth within this warranty. The manufacturer will not be responsible for any direct, indirect, or consequential damages, or for consequential loss arising from any failure.

Jurisdiction

This Limited Lifetime Warranty shall apply exclusively to the product installed in North America, be interpreted under New Jersey law, and any legal action relating to the Limited Lifetime Warranty shall be brought only in New Jersey courts which shall have the exclusive jurisdiction.

Disclaimer

No express or implied warranties have been made except for the Limited Lifetime Warranty made above. This Limited Lifetime Warranty and the associated Limited Lifetime Warranty remedies are provided in lieu of any and all other warranties and remedies. Except for the Limited Lifetime Warranty made above, the manufacturer disclaims all warranties expressed or implied, including without limitation any implied warranties of merchantability or fitness for a particular purpose. Anything to the contrary herein notwithstanding, under no circumstances shall the manufacturer be liable to the original purchaser or any other person or entity for special incidental, consequential or indirect damages, loss of personal items, loss of goodwill, business profits, work stoppage, any and all other commercial damages or loss, or exemplary or punitive damages arising out of or in connection with the product, whether based upon a claim or action of contract, warranty, indemnity, negligence, strict





liability, breach of statutory duty, contribution, or other legal theory or cause of action, even if advised of the possibility of such damages. This limited warranty does not include or cover directly or indirectly any related expenses for disassembly, fabrication, installation, or any losses that may be incurred as a result of the failure of the product. This Limited Lifetime Warranty does not apply to product that has been scratched, abraded or exposed to corrosive materials, usage of strong cleaning supplies/chemicals or applying any substance to the UV-protected side of the product. This Limited Lifetime Warranty does not include or cover loss due to environmental conditions including severe weather or atmospheric conditions including but not limited to gale force winds, acts of God, etc. If for any reason any portion of this warranty is held ineffective or void the remainder shall remain in effect.
